**5. Qualifications**

- ✓ Before applying for the rebate, applicant must purchase and install a new smart controller, washer or toilet(s). These devices must be installed at an address served by the West Kern Water District (WKWD) and identified with a WKWD account number.
- ✓ Applicant must submit a copy of the sales receipt indicating payment in full concurrently with the application.
- ✓ Rebates will only be paid for the purchase price of the device(s). This does not include tax, shipping, or installation.
- ✓ Washer Rebates: \$200.00 per washer with a limit of one washer per household.
- ✓ Toilet Rebates: up to \$150.00 per toilet with a limit of three per household and six per commercial site.
- ✓ Water Smart Controller Rebates: up to \$125.00. One per household.
- ✓ Do not submit application prior to installation. Rebate will only be issued after installation.
- ✓ Offer is void where prohibited or restricted by law.
- ✓ High-Efficiency toilet must be on the EPA Water Sense qualified list. Please visit <https://www.epa.gov/watersense/residential-toilets>
- ✓ Toilet must be replacing an existing high-water use toilet (3.5 gallons per flush or higher).
- ✓ High-efficiency Clothes Washers (HECW) must be on the (attached) qualified product list.
- ✓ Smart Controller must be on the approved list of controllers (Located at District Office).
- ✓ WKWD reserves the right to verify the purchase and installation of a qualifying washing machine, toilet, and/or smart controller. If, **for any reason**, WKWD is unable to conduct an inspection to verify purchase and/or installation, the rebate check may not be issued. If a rebate has been paid and an inspection cannot be conducted, the paid rebate will be subject to repayment to the WKWD. **WKWD may at its option obtain such repayment via an addition/charge to the monthly bill issued for the address/account located on the application.**

**Rebates are limited to first come first serve basis for up to:**

- ✓ Residential (single-family or in-unit multi-family):
- ✓ High-Efficiency Washing Machines: \$200.00
- ✓ High-Efficiency Toilet(s): up to \$150.00
- ✓ Smart Controller: up to \$125.00
- ✓ Rebates will CEASE when funding quota has been met.

**6. Please Note**

- ✓ Please allow two to six weeks for remittance of your rebate check, if your check has not been received after six weeks, please call Josh Hudson at West Kern Water District (661) 763-3151 Ext. 128.
- ✓ Incomplete applications cannot be processed.
- ✓ Check will not be issued for more than the purchased price. This does not include tax, shipping, or installation.
- ✓ West Kern Water District is not responsible for lost items or delays in the mail, or any remittance delayed because of incorrect or incomplete applications.
- ✓ If Applicant has a delinquent balance at the time the rebate is approved, the rebate amount will be first applied to the delinquent amount. If the delinquent amount is less than the rebate amount the remainder of the rebate will be left on applicant's account and applied to the applicants next water bill.
